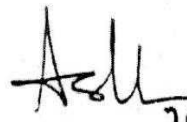

Sub: Withdrawal of RBV No.04/2008 and obtaining of vigilance clearance before posting an officer as Dy. CPO(Recruitment) through IRVINS.

Attention is invited to RBV No.04/2008, whereby guidelines for obtaining vigilance clearance before posting an officer as Deputy Chief Personnel Officer (Dy.CPO)(Recruitment) have been issued.

The said guidelines have been reviewed in the light of inception of Indian Railway Vigilance Information System (IRVINS). Now the Competent Authority has decided to withdraw the RBV No.04/2008. It has also been decided that the Vigilance clearance of the officer concerned before posted as Dy.CPO (Recruitment) may be granted by respective SDGM/CVO after obtaining the vigilance history of the officer concerned through IRVINS.

This has the approval of the Competent Authority.

**Sub: Guidelines for obtaining Vigilance clearance before
posting an Officer as Dy. CPO (Recruitment).**

It has come to notice of the Board that no Vigilance clearance is being taken before appointing an officer of Junior Administrative Grade/Selection Grade as Deputy Chief Personnel Officer (Recruitment) for recruitment of Group 'D' staff in terms of Board's letter No. E(NG)II/96/RR-1/62 dated 18.07.2007 (RBE No.121/2005).

2. Considering the sensitive nature of Group 'D' recruitments and the necessity that the incumbent to the post of Deputy Chief Personnel Officer (Recruitment) should be a person of impeccable credentials, it has been decided with the approval of the Board (MS) that posting to these posts shall be done only after obtaining prior vigilance clearance of the Board's Vigilance Directorate. The Vigilance clearance of Board's Vigilance Directorate shall be obtained through respective SDGM/CVO, who while making a reference to Board's Vigilance Directorate shall also give full vigilance history of the officer concerned as per details available with zonal Vigilance organization. Further, if the concerned officer had come on transfer during last one year, then vigilance history shall also be obtained from the zonal Railway/Unit where the officer was working previously, before making a reference to Board's Vigilance Directorate by SDGM/CVO.
