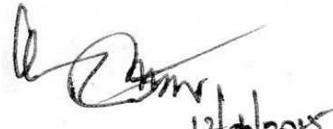

Sub: Permission for retention of Railway accommodation at the previous place of posting –reg.

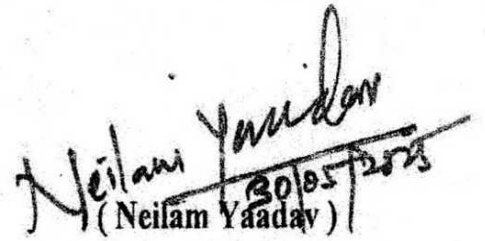
Ref: Board's letter of even No. dated 10.05.2024.

Attention is invited to above referred letter, vide which SAG & above officers posted at SWR were permitted to retain their Railway accommodation at previous place of posting up to 31.03.2025.

2. Now, on consideration of a request received from SWR, the Full Board in the exercise of the powers vested in it to make reasonable relaxations in public interest for a class/group of employees in all or any of the provisions regarding house allotment/retention, have decided that SAG & above level officers posted in SWR may be permitted to retain Railway accommodation at their previous place of posting for a further period of one year beyond 31.03.2025 i.e. up to 31.03.2026 subject to the conditions stipulated in Board's letter dated 01.07.2022.
